The report FY 2024-25 covers the operational performance of Mining Lease for the period from 1st April 2024 to 31st March 2025.

This Report presents information on the performances on Mining, Environment, Safety, Economic, and Social Responsibility for significant contributions to the sustainability and neighbouring communities where we operate. This Report has been prepared in accordance with the SDF Standards.

Our mining operation is located at Survey No. 21 of Megalahalli, Sy. No.35 of Tanigehalli and Sy. No.1 of Chowdenahalli Villages, Holalkere and Chitradurga Taluks, Chitradurga District in Niruthadi Reserve Forest over an area of 42.13 hectares. Mining lease was granted in the year 1977 and is valid till 3rd February 2027. We are adhering to all Legal and other requirements and complying the terms and conditions in a time bound manner.

Our first priority is the safety of our employees and the people who live in the communities where we operate. As a process of Continual Improvement Programme enhancing skill levels of employees through structured training and capacity building, conducting Internal Audits, and external Audits and complying the findings of the Audits.

Third Party Environment Audits, Energy Audits were carried out for the year 2024-25. Compliance with respect to Legal and Other Requirements were met in totality.

EXPLORATION & MINE PLANNING

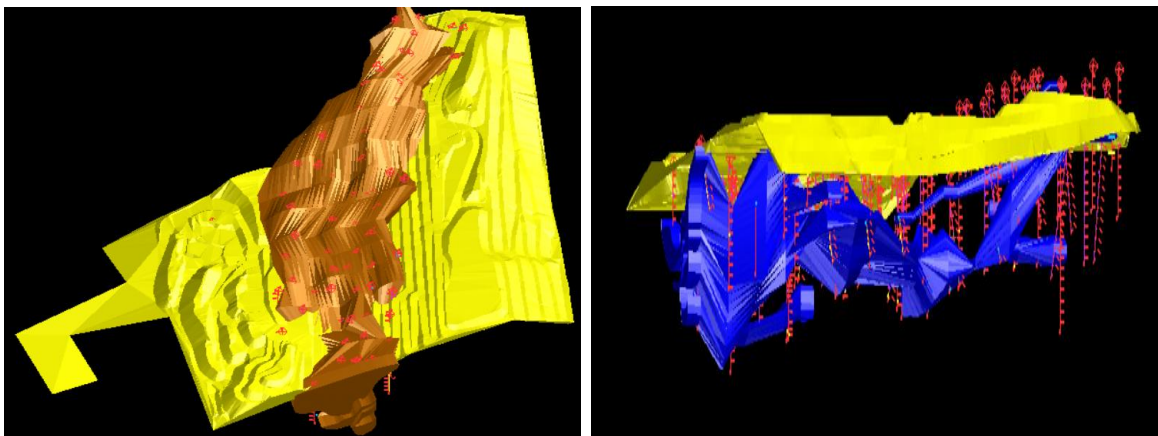
Out of 42.13 Ha of lease area we have carried out in-house exploration by core drilling method as well as drilling by RC method. We have drilled total of 9868.40 meters with 83 No's of boreholes and converted the entire mineralised zone into G1 Category. It is evident from exploration that 49.66% of lease area is declared as mineralised zone.

During the FY 2024-25, 14 boreholes were drilled by RC method to prove the mineralisation at vertical dimension as well as to establish the ore body contact. Exploration samples were analysed at NABL accredited laboratory and legal requirements of exploration has been met.

Inputs of mineral exploration has been used for Mineral Characterization and Preliminary Beneficiation studies of the lean grade iron ore with Council of Scientific and Industrial Research (CSIR). Reserves and Resources were re-estimated in the Modified Approved Review and Updation of Mining Plan is 33.68 million tonnes at the end of the FY 2024-25 under G1 (111) category of UNFC.

MINING OPERATIONS

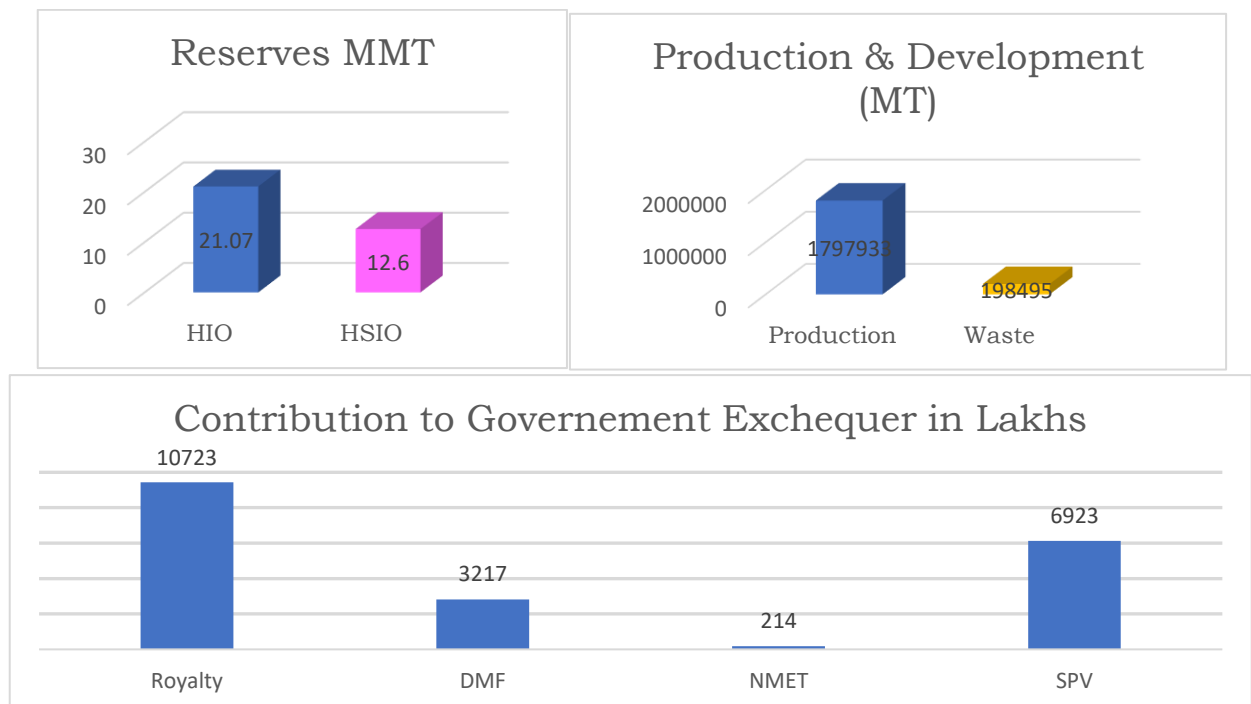
Eco- friendly Scientific and Systematic Mine operations have been carried out using Dumper and Shovel Combination.

Production and Development has been carried out in accordance with IBM approved Mining Plan and 17,97,933 metric tonnes of Iron Ore having average grade of Fe 57.00% was mined during FY 2024-25.

Iron ore was sold via E-Auction/Purchase Order to local steel manufacturers in Karnataka and Andhra Pradesh and exported from Goa and Panambur sea port. There were no Customer Complaints pertaining to Quality of Material registered during 2024-25.

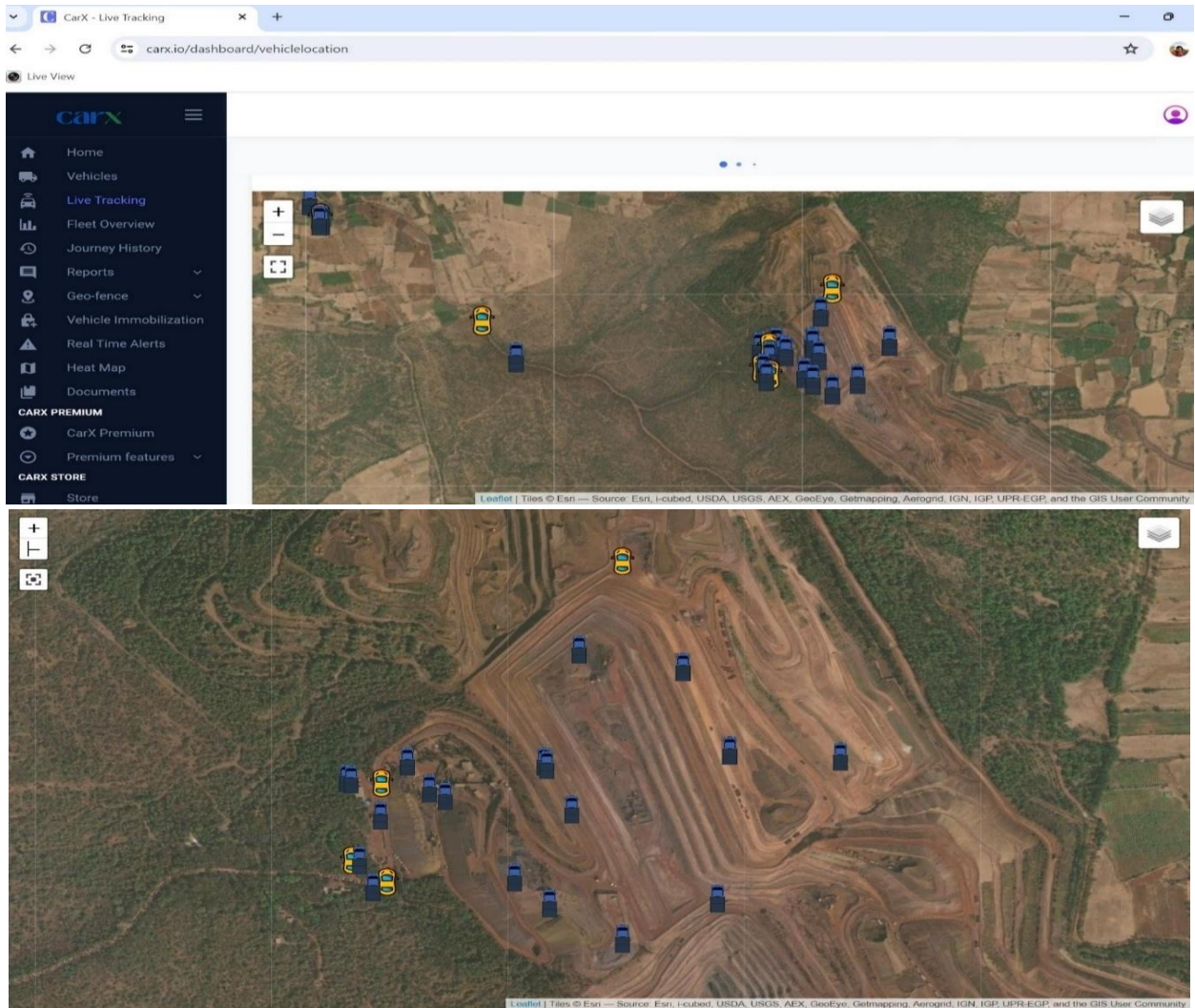
John Iron Ore Mine of R. Praveen Chandra adopted the Integrated Management System that encompasses ISO 9001:2015 Quality Management System, ISO 14001:2015 Environment Management System and ISO 45001:2018 Occupational Health and Safety Management System from Bureau Veritas for the sustainable and zero waste mining.

Waste dumping has been carried out in earmarked area as per the approved mining plan. As a part of the dump management practice the retaining wall having length of 842 running meters at the toe of each dump has been constructed during RY. Inactive dump terraces were covered with Geo-textile coir mats covering 9500m² and dump area of 0.95 ha afforested with native species during the RY.



SAFETY IN OUR OPERATIONS

Proactive measures have been taken for Safety in all our operations. Advanced technology like Proximity Warning Devices, Audio-Visual Reverse Camera, Fatigue Monitoring Device, GPS enabled Fleet Management System has been put in place for Dumpers.

Height, Width of Benches, Bench Slope are maintained as per safety norms as required under MCDR, 2017 and MMR, 1961. Pit Slope Stability study has been carried out in 2020-21 by NITK, Suratkal and overall slope maintained to 22 to 23° and Dump Slope study has been carried out in 2021-22 by NITK, Suratkal and average slope maintained to 29 to 34°.

Hazard Identification and Risk Assessment has been carried out across all our operations and Controls has been established.

Tripartite Meeting were held on implementation of recommendations of 12th conference of safety at mines on 02nd February 2024. Safety Management System, Work Permit, One Day Safety Officer, Lock Out Tag Out Procedures, Work Instructions, Operational Control Procedures have been established.

Emergency Preparedness Plan, Mock Drills, Trainings are conducted on regular basis. Workmen Participation in Occupational Health and Safety Management System is ensured by engaging them in identification of HIRA, Pit Safety Committee.

ENVIRONMENT SUSTAINABILITY



We recognise that the balancing the environmental performance is a critical component of our business. We are committed to monitoring and managing the environmental impacts of our activities to secure sustainable environmental future for communities surrounding our sites, even after our operations cease. Afforestation in a staged manner, dust suppression by scientific methodologies, conservation of natural resources with zero waste mining and strict implementation of reclamation and rehabilitation programme on time bound manner.

Company's commitment is not only to maintain but enhance our 'licence to operate' and our goal is to go beyond compliance and adopt a leading practice approach.

We comply with all environmental laws and implement environment standards in line with ISO 14001:2015 for which we are certified from Bureau Veritas.

OPERATIONAL HIGHLIGHTS

Mining activities, by nature, have significant impacts on the environment, especially when not pursued in a responsible manner. The negative impacts of mining activities include water depletion, de-forestation, pollution, and increased greenhouse gas emissions. The public perceives that the mining industry contributes to environmental destruction. Therefore, it is critical that mining companies manage their environmental impacts properly. We at John Iron Ore Mines strive to implement best practices in environmental management that adhere to the principles of responsible mining.

Nature of our mining operations, proper management of natural resources is part of our business ethics and is integrated in our overall approach. The organisation implements a comprehensive environmental program that addresses all phases of mining, from exploration, mine development, operations, and Progressive Mine Closure. As a part of the sustainable mining and environment care objectives two electrically operated dumpers have been adopted in the mine.

Mine environmental program is comprised of management initiatives for land resources, water resources, hazardous and toxic waste, and air quality, as well as the activities of enhancing of green cover, promoting Bio-diversity conservation measures.

During FY 2024-25, we have planted 18,485 saplings within the lease area and 13,890 saplings outside the lease area with 65% survival rate within mining lease and 35 % outside the mining lease.

Construction of 06 No.s of vertical drain over a length of 28 meters each to a total of 168 meters being proposed and the work has been initiated during the reporting year. The retaining wall has been constructed at the toe of the inactive

dump over a length of 642 meters and the Garland Drain work also initiated. De-silting of engineering structures was also carried out as and when required.

Compliances to all applicable Environment and Forest laws/conditions are carried in time bound manner. Environment Monitoring in core and buffer zones are carried through NABL accredited and the MoEF & CC recognised third party laboratory and monitored results are well within permissible standards.

Disposal of hazardous waste oil is done through “Registered Recycler” and legal compliances are met with. 59.00% of generated hazardous waste oil has been disposed during FY 2024-25.

Recharge structures like rain water harvesting pond at our own nursery area, check dams, gulley plugs, settling pond which were previously constructed has been maintained for augmentation of Ground Water. Hydrogeological Studies were carried out surrounding 5km of mine lease area.

Organic waste from the canteen is used for vermicompost in a facility made at our nursery area with a capacity to raise 50,000 saplings annually.

Innovative technologies like dry fog dust suppression systems at the input bunker of processing plant, hydraulic sprinkler fitted to the water tanker have helped in conservation of water. The consumption of water was 0.024 Kilolitres per Metric tonne of production in the RY. We have utilised only 43,128 KL for the RY out of total sanctioned capacity 76,153 KL of ground water per annum.



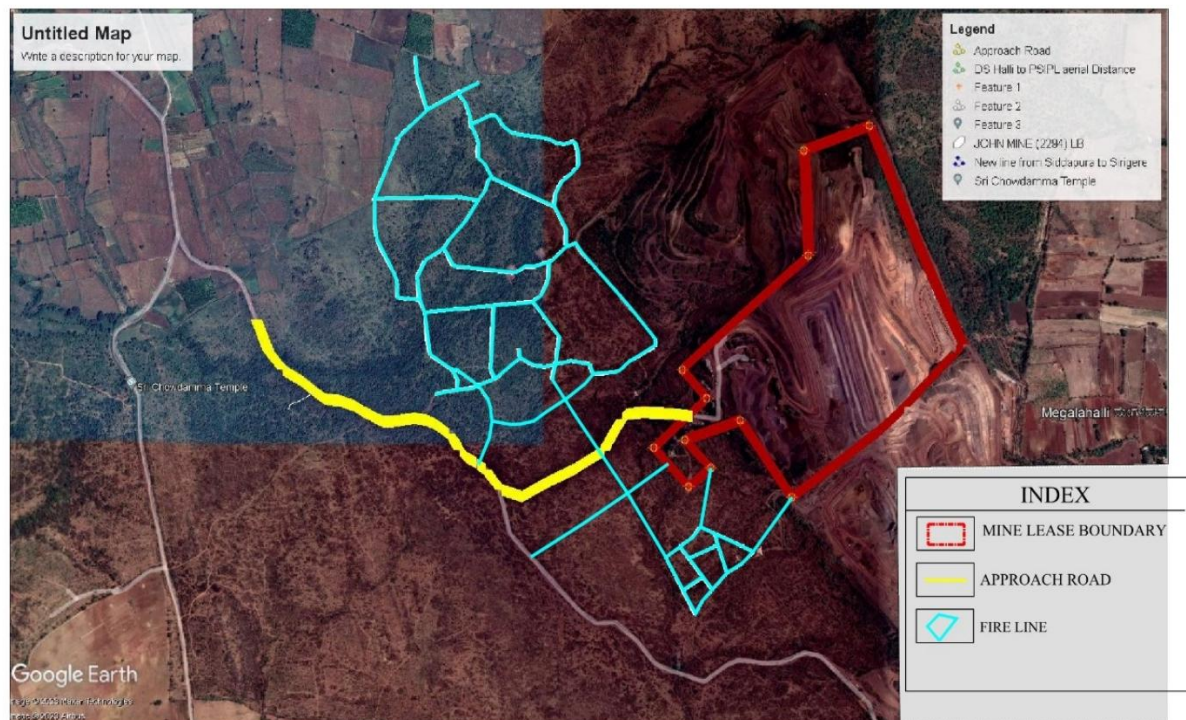

Efforts have been made in association with ICFRE-Dehradun for identification of RET species in the mining lease area and to relocate the same to Nursery for raising these climbers and to plant them on in-active dumps.

Forest Fire lines of 5.1 kilometres have been made under the guidance of Range Forest Officer, Holalkere Range around the mining lease area.



Activities under Wild Life Management Plan included

- Making of Water troughs in forest area for quenching thirst of animals.
- Erection of Pergola Makan at Niruthadi Forest area and its maintenance.
- Conducting awareness programs on importance of Wild Life Management and forests by putting public hoardings.

During the year 2024-25, the mining area received 1023.9 mm of rainfall. For 2024-25, there were no incidents of non-compliance with environmental laws and regulations. As a mining organization, we adhere to the Environment Protection Act 1986, also relevant rules and regulations governing Mining and the Environment.

Soil & Moisture conservation - R & R Work

At the same time the Soil and Moisture Conservation measures have been taken inside and outside the mining lease area by constructing the Retaining wall, Check dams, Gully checks, Garland drains, by spreading Geo-textile/coir mat over waste dump, grassification and afforestation.

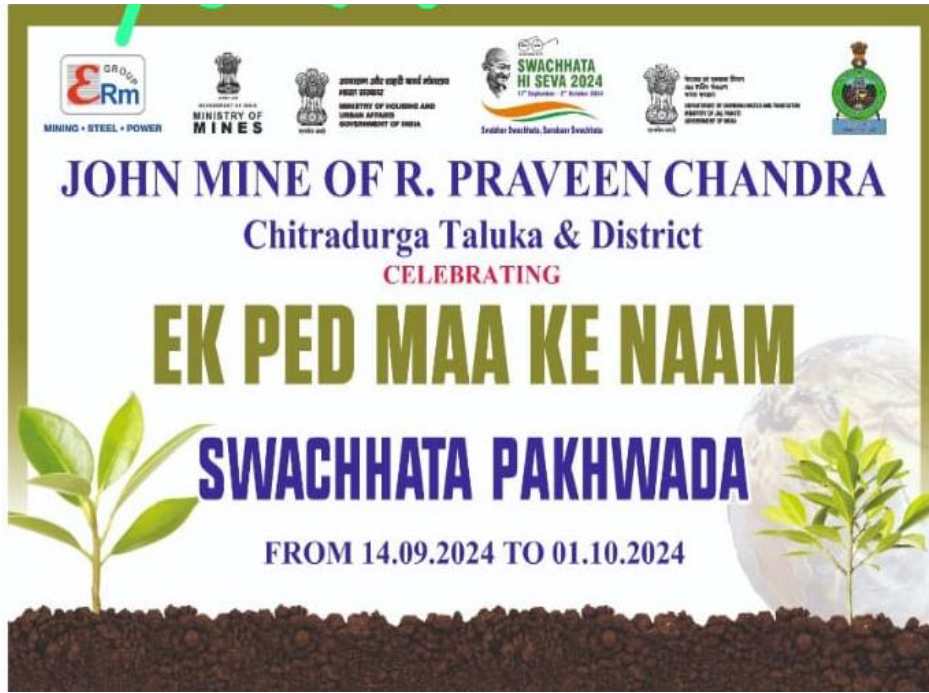

In an effort to improve access to education for children in remote mining villages, a new school bus facility has been introduced to transport students to nearby schools. Many families residing in these areas face significant challenges in sending their children to school due to the distance, lack of proper roads, and financial constraints. The school bus service aims to eliminate these barriers, ensuring that every child has the opportunity to attend school regularly.

The buses operate on a fixed route, covering multiple villages and picking up students at designated stops. This service not only provides convenience but also ensures the safety and security of students as they travel to and from school.

Two Nos. of School Bus Maintained: Convenience is very important for students of villages situated away from Schools/Colleges and lower socio-economic status of the family, it helps students attend their classes regularly and helps to make their academic year better. To facilitate education and to improve logistics for school and college going children, the facility of school buses has been extended in 2024-25

Rout 1: D. Medikeripura, Doddiganhall, Siddapura, Hosatti to Sirigere. Daily about 375 students are being benefited from this service offered by the company

and Annual cost of this facility around Rs. 12,50,000. Costs incurred as maintenance of school bus Driver & Helper salary and HSD cost.

Route 2: Muthugaduru , Kagalagere, Siddapura, to Sirigere. Daily about 130 students are being benefited from this service offered by the company and Annual cost of this facility around Rs. 15,00,000. Costs incurred as maintenance of school bus Driver & Helper salary and HSD cost.

Route 3: From Megalahalli village 36 students was studying in Sirigere and it is remote village where people use to walk for 2.5 Kms from village to main road here the company has extended the financial assistance to all 38 students for FY 2024-25 and paid the school bus fees so that institute may sent the bus facility to those students. Rs. 2,50,000.00 spent for providing school bus facility from Megalahalli village to Sirigere.

Infrastructure Development

Value Addition



With a vision to add value to iron ore, ERM Group has ventured into sponge iron manufacture through sister concern M/s. Prakash Sponge Iron and Power Pvt. Ltd., located at about 75kms from the mine in Chitradurga District. ERM group's steel making entity, Prakash Sponge Iron and Power Pvt. Ltd, at Challakere in Karnataka, covers area of 200 acres & manufactures high grade mild steel. As forward integration, we use induction furnace and superior equipment such as MSS Convertor and LRF (Ladle Refining Furnace) to produce high quality liquid steel.

This is then cast by the Continuous Casting Machine to produce Low Phosphorous Sulphur (LPS) Mild Steel Billets and now recently into steel Re-bars. Turbosteel is a brand promoted by Prakash Sponge Iron and Power Private Limited (PSIPL). PSIPL located at Heggere & Kaparahalli villages in Challakere taluk of Chitradurga district, Karnataka manufactures high grade mild steel.

PSIPL entered into the enhancement of value addition by setting up of a pellet plant with a capacity of 1.0 MTPA.

Setting up Integrated Steel Plant under through ERMMPPL at Navile Basapura Village, Bhadravati Taluk, Shimoga Dist. Work has already been started for commissioning of Re-Bar Rolling Mills.
